Many of the safeguarding concerns we now deal with in school have some form of online element – whether linked to friendships, self-esteem, peer pressure, harmful content, or inappropriate contact.

This SWGfL training will provide parents with a clear and up-to-date understanding of the online world our students are navigating every day. The interactive presentation will include:

- Practical advice and strategies for staying safe online
- Resources to help you support and guide your child
- Clear information about risks, settings, privacy and reporting
- Guidance on building healthy, balanced and positive online habits
- An opportunity to ask questions directly to the trainer
